Or possibly it is because of the deep conversations we had when our ferry was cancelled and we were stranded together on an island for almost 2 hours.

CAPAJA's weekend in San Francisco from Nov. 14-16 was a huge success because we had all of these experiences.



Over 40 people participated in part, or all, of the activities during the weekend. Seven judges flew from SoCal to join in the fun, and we were able to get to

It was an incredibly moving experience to hear from our knowledgeable guide about the immigrant experiences and to read the poetry etched into the walls by the detainees. That evening, we had a reception to warm up from the ferry ride and catch up with more judges who live near San Francisco. We ended the weekend on Sunday with a delicious dim sum brunch.

Huge thanks to Roberta Hayashi, Hanley Chew, Marisa Chun, Delbert Gee, Jacqui Duong, and Tracie Brown who worked together to organize a weekend full of good food and activities. 




A re-creation of the room and bunks at the detention center at Angel Island. Some people were held here for a few weeks to months, but some were detained for several years.






CAPAJA Member to be Honored by California Judges Foundation


