#### **Governor Newsom Announces New API Judicial Appointments**

On February 17, the Governor announced the appointments of three new API jurists:

**Judge Danny Chou** of the San Mateo County Superior Court has been nominated to serve as an Associate Justice of the First District Court of Appeal, Division Five. Soon-to-be-Justice Chou has been on the Superior Court since 2018 and his new position requires confirmation by the Commission on Judicial Appointments.

**Gary Eto** has been appointed to the Los Angeles Superior Court. This appointment is particularly welcomed as he is filling the vacancy created by the retirement of CAPAJA Member Fred Fujioka.

**Joseph Kang** has been appointed to the Orange County Superior Court. This is another welcome appointment, as he fills the vacancy created by the retirement of Past CAPAJA President Kirk H. Nakamura!
