CAPAJA Organizes Amazing Tour of Japan

The inaugural travel tour sponsored by CAPAJA was a great success! Under the leadership of CAPAJA Travel Committee Co-Chairs and Past Presidents, SCSC Judge Roberta Hayashi and LASC Judge Teresa Magno, 16 active or retired California judicial officers and some of their family members visited Osaka, Kyoto, Hiroshima, Hakone and Tokyo between November 1 – November 11, 2023. The activity-packed tour included a welcome lunch with the U.S. Consul to Osaka-Kyoto, a Judicial Symposium at Temple University School of Law – Japan Campus, sightseeing in Kyoto and Hakone, a visit to Japan's Supreme Court, and a farewell dinner on a river boat on the Sumida River. Judge Shingo Hidaka (introduced to us by Judge Holly Fujie) was our host at the Supreme Court as well as the organizer for an informal reception in Shibuya. Thanks to our CJA affiliate status, CJA helped publicize the tour and provided JEC and MCLE credit for attendees at the symposium, at which Judges Magno and Hayashi spoke on two of the panels, and CAPAJA member Judge Sabina Helton moderated a panel on jury trials in Japan and California. Judge Magno worked closely with our tour coordinator, Jia Xie of Be Abroad, who was introduced to us through CJA. Jia did a wonderful job and exceeded expectations. The program was universally lauded as a complete success and is a wonderful beginning to what is hoped will be an annual trip abroad for CAPAJA.
