CAPAJA Members Profiled in DJ

On August 2, the Daily Journal published a profile of CAPAJA Member Orange County Superior Court **Judge Vibhav Mittal** in an article entitled "Supervising other prosecutors prepared Judge Vibhav Mittal for the bench." The article discusses Judge Mittal's commitment to the collaborative approach to the law which he experiences on the juvenile court. Judge Mittal is quoted as saying "It is, I think, the ultimate public service job, working in this courtroom, working with families and kids, and I don't think anything can be greater than that." Excellent sentiments, Judge Mittal!

On August 7, **Judge Ernest Hiroshige** of the Los Angeles Superior Court was profiled in the Daily Journal and announced that he would seek reelection next year. Judge Hiroshige was a Deputy District Attorney before his appointment to the South Bay Municipal Court in 1980 and his elevation to the Superior Court in 1982. Judge Hiroshige is now the most senior judge sitting on the Los Angeles Superior Court bench.

On August 10, CAPAJA Member **Judge Mark Singerton** was profiled in the Daily Journal under the title "Judge Mark Singleton invests in troubled minors' lives." The article chronicles how Judge Singerton became Riverside County's first Japanese American judge in 2021. It describes how he mentored minors when he was with the Riverside County District Attorney's Office and how he now helps administer the mentoring program as a judge. "Defense attorneys say their clients are on the path toward being productive members of society thanks to Singerton."
