We hope you all had a great holiday season as we leave 2020 behind and start the new year. Finally! Here is the CAPAJA news for January.

New APA Judges

On December 9, 2020, Governor Newsom appointed two new APA Superior Court judges. Keith Fong was appointed to the Alameda Superior Court and Jinsook Ohta was appointed to the San Diego Superior Court.

That same day, the Governor appointed CAPAJA Member San Diego Superior Court Judge Truc Do as the first APA woman on the 4th District Court of Appeal, and the first Vietnamese American to serve on any of the California State Courts of Appeal.

This month these APAs who were elected in 2020 will start their judicial careers: Lana Kim (LASC), Scott Yang (LASC), Linda Sun (LASC), Jeff Mangar (Stanislaus SC) and CJ Mody (SDSC).

The new judges have received complimentary inaugural CAPAJA memberships through 2021 and will soon be actively involved in our organization.

Justice Ming Chin Honored by CLA

Member and California Supreme Court Justice (ret.) Ming Chin was given the California Lawyers Association's highest honor, the Bernard E. Witkin Medal in a virtual award ceremony. Congratulations to Justice Chin on receiving this well-deserved and very prestigious honor.

CAJAC Reception for Justice Martin Jenkins

On December 9, 2020, CAPAJA co-sponsored a CAJAC (California Affinity Judges Association Coalition) Zoom Celebration of the Appointment of Martin Jenkins to the California Supreme Court (filling the seat vacated by Justice Chin). President Holly Fujie spoke on behalf of CAPAJA about Justice Jenkins' career and thanked him for his role in Governor Newsom's appointment of 16 APAs to the Superior Courts and Justice Do's appointment that day to the DCA.

On December 10, 2020, Governor Newsom announced the appointment of his new Judicial Appointments Secretary, Luis Céspedes, Esq. of Sacramento. The announcement included a quote from CAPAJA member Russell L. Hom, Presiding Judge of the Sacramento County Superior Court, praising Mr. Céspedes' "deep sense of community" and his work "to improve the legal profession and the judiciary."

Judicial Applicant Mentoring Program Launched by the LA Superior Court

The LA Superior Court has created a Judicial Applicant Mentoring Program under the auspices of the Governor's office to help lawyers seeking appointment by the Governor to a judicial position by providing them with a Judge-Mentor to encourage and assist them in the process. Lawyer-Mentees must be members of the California bar in good standing for at least ten years and within two years of intending to apply for a judicial appointment. Judge-Mentors will provide advice and guidance on the process of applying and on what candidates can do to improve their chances of appointment. The program is not meant for those who have already submitted their applications. CAPAJA member Judge Audra Mori is co-chair of the LASC

Mentor Program Outreach Sub-Committee.
