CAPAJA General Meeting Held on April 12!

On April 12, CAPAJA held its Mid-Year General Meeting. Led by President Judge Sonny Sandhu and President-Elect Judge Terry Truong, over 50 judicial officers participated in the meeting, receiving updates on the activities of CAPAJA and its many extremely active committees. <u>CAPAJA Membership Approves Process for Endorsing Candidates for the</u> <u>California Court of Appeals</u>

At the CAPAJA April 12, 2023 Mid-Year Meeting, the membership voted unanimously to approve the board's proposed Guidelines for Endorsing Superior Court Judicial Officers for the Court of Appeals. These Guidelines build upon the success we've enjoyed in endorsing candidates for the superior court, and they advance our core mission of promoting excellence and diversity in the judicial branch. The endorsement process for the Court of Appeals is limited to candidates who are superior court judicial officers.

Candidates must initiate the endorsement process by submitting a written request to CAPAJA, together with all documents submitted to the Governor (including, but not limited to, a copy of the candidate's Personal Data Questionnaire). Unlike CAPAJA's process for endorsing candidates for the superior court, candidates for the Court of Appeals are not required to submit a letter from a Judicial Sponsor.

The CAPAJA board will consider those factors applicable to evaluating superior court candidates generally, with an emphasis on factors relevant to an appellate court appointment (e.g., intellectual capacity, writing ability, scholarship, collegiality, Court of Appeal pro tem experience, teaching experience, etc.). After the CAPAJA Board votes to endorse a candidate, the CAPAJA President will deliver a letter of endorsement to the Governor's Judicial Appointments Secretary and to the candidate.

The process of endorsing candidates for the Court of Appeals is confidential. CAPAJA may endorse more than one candidate for a District Court of Appeals. Requests for endorsement, together with all documents submitted to the Governor, should be emailed to <u>capaja2020@gmail.com</u>.
