Governor Newsom Appoints More APAs to the Superior Court

On August 8, the luckiest day of the year, Governor Brown selected Commissioner and Judge-Elect Pelayo A. Llamas Jr. of Alameda County, already an active member of CAPAJA, for an interim

appointment as Judge of the Superior Court for Alameda County. This allows Judge Llamas, who had been endorsed by CAPAJA, to immediately commence his work in the seat to which he was elected and would otherwise start occupying in January 2023. The act is personally meaningful to Judge Llamas and to CAPAJA because it is the judicial seat of Judge Delbert Gee, who will be retiring this year after 20 years of service on the Superior Court bench.

Also appointed on August 8 was Raymonn DeJesus, who received CAPAJA's endorsement for appointment to the Placer County Superior Court, and Pahoua Lor, who was appointed to the Fresno County Superior Court. What a great day for API judge appointments!

Judge Charles J. Lee Profiled in Daily Journal

Fresno Superior Court Judge Charles J. Lee was profiled in the September 15 edition of the Daily Journal. The title of the article was "Judge Charles J. Lee encourages minority lawyers," and it highlighted his background as the son of Korean immigrants who came to the U.S. in the early 1970's. Judge Lee stated in the article that "one of the reasons he decided to apply for a judgeship was a chance to make the bench more reflective of the region's demographics. Looking for Judges Fluent in Mandarin to Translate Judges in the Classroom Script

Judges in the Classroom (JIC) connects public school teachers with volunteer judges for lessons on the role of the judiciary, the three branches of government, rule of law, and other areas of civics. The program is supported by the Chief Justice's Power of Democracy Steering Committee. Participating judges appear in classrooms in person or via zoom to present one of four grade-appropriate lessons. In an effort to provide access for ESL students, two lessons are now available in Spanish and one is available in Mandarin. There is great value in these translations because they are delivered by language fluent judges in immersion classes with non-English speaking students. JIC is seeking judges fluent in Mandarin to translate the script for the Salem Witchcraft Trials presentation. The script is read by students and vividly illustrates how trial procedures have changed from the 1600's to the present.
