Thank you to everyone who completed our Initial Membership Survey. We received over 92 responses! CAPAJA and its committees will use the information provided internally to undertake projects and programs to serve our membership.

The survey revealed that CAPAJA has a talented, experienced, and diverse membership. The respondents had an average of over 10 years of experience on the bench and have held assignments in all the areas listed on the survey (appellate, criminal, civil, family law, juvenile, and probate) and many others not listed. CAPAJA's members are also experts in every one of the 22 categories listed on the survey and many more (DV, ethics, civil harassment, elder abuse, immigration, bankruptcy, administrative law, traffic, small claims, etc.).

In addition, CAPAJA members have served in just about every leadership role in the courts, including five presiding judges and numerous supervising judges of appellate, criminal, civil, family law, juvenile, traffic/infractions, mental health, DV, collaborative, asbestos, CEQA divisions, teams, and panels, as well as branch courts and districts. Santa Clara's AAPI Bench Officers Present Their Stories to Their Court

On April 12, all thirteen AAPI bench officers on the Santa Clara County Superior Court presented a crucial conversation. Under the leadership of Judge Jacqueline Duong, who co-chairs that court's Equality and Social Justice Committee with Judge Shelyna Brown, the AAPI judges shared their personal experiences with discrimination against them and their families.

It was a rich and powerful conversation that ranged from the sharing of immigration stories to the incarceration of Japanese American families during WWII to intersectionality with gender and multicultural ancestry, to childhood bullying and more. These stories were told against a backdrop provided by Chief Justice Tani Cantil-Sakauye, who opened the discussion with a video message about the importance of personal stories. Overlaying these stories were photographs of the judges as children.
