NEWS

New API Bench Officers Welcomed to CAPAJA!

June has brought good news for the appointment of new API bench officers. On June 3 we learned of the appointment of June An as a Commissioner by the judges of the Orange County Superior Court. Soon-to-be Commissioner An was the OCSC's Deputy General Counsel at the time of her appointment.

That same day brought news that Sandy Yu, a fellow Board Member with Judge Holly Fujie of the Asian Pacific American Women Lawyers Alliance of Los Angeles, has been appointed as an Administrative Law Judge for the California Department of Social Services State Hearing Division.

Also on June 3, Governor Newsom appointed two new API Superior Court Judges! Assistant Federal Public Defender Gia Kim was appointed to the Los Angeles Superior Court, and Commissioner and Superior Court Senior Legal Research Attorney Trisha Hirashima was appointed to the Placer Superior Court.

And on June 7, CAPAJA learned from Judge Paul Baelly of the Ventura County Superior Court that Dusty Kawai has been named as a Commissioner of the VCSC.

The June 7 election brought victory for three API candidates to the Superior Court: CAPAJA member and volunteer webmaster Pelayo Llamas won election to the Alameda County Superior Court which he currently serves as a Commissioner; CAPAJA member Jayne Chong-Soon Lee was elected unopposed to the San Joaquin Superior Court; and Deputy D.A. Sharon Cho was elected to the San Mateo Superior Court. Commissioner Llamas and Ms. Cho will take their judicial office in January 2023.

On June 9, the U.S. Senate confirmed the appointment of Robert S. Huie, of counsel at Jones Day, as a U.S. District Court Judge for the Southern District of California.

On June 16, the Commission on Judicial Appointments, consisting of CAPAJA member Chief Justice Tani Cantil-Sakauye and the first API Attorney General of California, Rob Bonta, together with Presiding Justice Manuel Ramirez of the 4th DCA, confirmed the appointment by Governor Newsom of CAPAJA member and co-chair of CAPAJA's Education Committee, Joanne Motoike, as the newest Associate Justice of the California Court of Appeal, Fourth District, Division 3.

Lastly on July 1, Governor Newsom appointed two new API Superior Court judges in Riverside County - Mona Nemat, a partner at Best & Krieger and Jerry Yang, a Chief Deputy of the Riverside branch of the U.S. Attorney's Office for the Central District of California since 2020!

All new bench officers have received or will receive email greetings from CAPAJA with offers of free membership to the end of 2022 and assignment of a CAPAJA judicial mentor. Please join us in giving a warm CAPAJA welcome to all our new bench officers!
