CAPAJA Member Nominated to 6th District Court of Appeal

Governor Gavin Newsom appointed former CAPAJA Board member Santa Clara Superior Court Judge Cynthia C. Lie to be an Associate Justice of the Sixth District Court of Appeal on July 9. Judge Lie has served as a Judge of the SCSC since 2015 and fills the position vacated by the retirement of CAPAJA member Nathan D. Mihara. Congratulations, soon-to-be Justice Lie!

Governor Newsom Appoints 4 APIs to the Superior Court

Also on July 9, Governor Newsom appointed four APIs to the Superior Court – two of whom had been endorsed for appointment by CAPAJA: Stephanie Sato to the Alameda Superior Court and Marisa Chun to the San Francisco Superior Court. Soon-to-be Judge Sato has been an Administrative Law Judge for the California Unemployment Insurance Appeals Board since 2021. Judge-Elect Chun has been a partner at Crowell & Moring LLP since 2019. In addition, Aruna Rodrigo and Jerry Bustos Vinluan III were appointed to the San Bernardino Superior Court and Santa Cruz Superior Court, respectively. Congratulations, all of you!
