Three API appointed to across California

On May 19, Governor Gavin Newsome appointed 27 Superior Court judges across California, and 3 of them are API. Diana Tsang (Los Angeles) is from the LA County Public Defender's office, Marsha Amin (San Diego) is the Managing Attorney for the Fourth District Court of Appeals, and Sweena Pannu (Stanislaus) is a Deputy County Counsel. Eastern District CA Federal Judge, CAPAJA Member Anthony Ishii Retires

The May 10 Daily Journal reported that U.S. District Judge for the Eastern District of California, CAPAJA Member Judge Anthony W. Ishii, retired on April 30 after twenty-six years on the federal bench. Judge Ishii, who served as a Justice Court Judge for ten years before being appointed to the state court bench in 1983 and the federal bench in 1997, noted in the article: "When I came to the federal bench, there were only four Asian American judges in the entire country. I didn't think of myself as a real trailblazer or anything, but to the extent that I can be a role model, I certainly tried to." CAPAJA notes that NAPABA, which named Judge Ishii a Daniel K. Inouye Trailblazer in 2006, would beg to differ from his modest disavowal of trailblazer status. The article continues to quote attorneys who appeared before Judge Ishii, who "praised his attention to detail on every case, despite his heavy docket, and described him as someone who was knowledgeable, respectful, meticulous and funny." CAPAJA is proud of Judge Ishii's long record of service and his longstanding involvement with CAPAJA. We wish him a long, healthy and happy retirement (and hope he will continue to attend CAPAJA gatherings)!

CAPAJA Member Confirmed to the U.S. District Court

On May 3, CAPAJA Member and former committee chair LASC Judge Wesley Hsu was confirmed by the United States Senate on a 53-43 bi-partisan vote to serve as a U.S. District Court Judge for the Central District of California. Judge Hsu, who was appointed to the Los Angeles Superior Court in 2017, was sworn into his new federal seat on May 19, with many CAPAJA members looking proudly on. Judge Hsu sends this message to all CAPAJA members: "I am incredibly grateful to CAPAJA for supporting me these last five and a half years. I hope to see you all at the next CAPAJA meeting!" CAPAJA Mentoring Circles

CAPAJA provides small group mentoring for new bench officers. Last year, there were five groups, each with 4-5 new bench officers and with one experienced judge to lead the discussion. For 2023, three new Mentoring Committees have formed, and each one is based on practice area. These small groups meet virtually once a month to provide a forum for the members to discuss common issues that all new bench officers face such as dealing with self-represented litigants, 170.6 motions, interactions with staff, and judicial security off the bench. So far, the 2023 Mentoring Circles members include:
