CAPAJA Talk with Việt Thành Nguyễn - 8/10/22 at 4:45 pm

Please join us for a special *CAPAJA members-only* talk with Pulitzer-winning and NYT's best-selling author Việt Thành Nguyễn on Wednesday, August 10 at 4:45 pm via Zoom. Viêt Thành Nguyễn's novel *The Sympathizer* won the Pulitzer Prize for Fiction. His most recent publication is the sequel to *The Sympathizer, The Committed*. His other books are *The Refugees; Nothing Ever Dies: Vietnam and the Memory of War*; and *Race and Resistance: Literature and Politics in Asian America*. He has also published *Chicken of the Sea*, a children's book written in collaboration with his son, Ellison. He is a University Professor, the Aerol Arnold Chair of English, and a Professor of English, American Studies and Ethnicity, and Comparative Literature at the University of Southern California. He is also a recipient of fellowships from the <u>Guggenheim</u> and <u>MacArthur</u> Foundations, and a Fellow of the <u>American Academy of Arts and Sciences</u>. He is a regular contributor as an <u>op-ed</u> columnist for <u>The New York Times</u>, covering immigration, refugees, politics, culture and South East Asia, and also serves as cultural critic-at-large for <u>The Los Angeles Times</u>.

He was born in <u>Ban Mê Thuột</u>, <u>Vietnam</u> in 1971, the son of <u>refugees from North Vietnam</u> who moved south in 1954. After the <u>fall of Saigon</u>, in 1975, his family fled to the United States. His family first settled in <u>Fort Indiantown Gap</u>, Pennsylvania, which was one of four American camps that accommodated refugees from Vietnam. After living in <u>Harrisburg</u>, <u>Pennsylvania</u> for three years, Professor Nguyễn and his family moved to <u>San Jose</u>, <u>California</u>, where they opened up a Vietnamese grocery store, one of the first of its kind in the area. After receiving his <u>Ph.D.</u> in English from Berkeley in May 1997, he moved to Los Angeles for a teaching position as an assistant professor at the <u>University of Southern California</u> in both the English Department, and in the American Studies and Ethnicity Department. In addition to teaching and writing, Professor Nguyễn is the co-founder of the <u>Diasporic Vietnamese Artists Network</u>.

<u>President Biden Nominates CAPAJA Member Rita F. Lin to U.S. District Court for the Northern District of California</u>

On July 19, 2022, President Joe Biden nominated CAPAJA Member and San Francisco Superior Court Judge Rita F. Lin as a District Judge of the Northern District of California. When confirmed, Judge Lin will be the first Chinese American woman to serve as an Article III judge in that District.

Judge Lin was appointed to the San Francisco Superior Court in 2018. Before her appointment, she was an Assistant U.S. Attorney and a partner at Morrison & Foerster. In 2017 she received NAPABA's Best 40 Under 40 Award.

Congratulations to Judge Lin and CAPAJA's best wishes for a speedy confirmation.

Chief Justice Announces Retirement From the Judicial Branch

On July 27, CAPAJA Member Chief Justice Tani Cantil-Sakauye announced that she would not be seeking re-election to the Supreme Court and would retire from public service with the Judicial Branch as of January 1, 2023. The Chief, who was the second woman and the first API and woman of color to serve as Chief Justice of the California Supreme Court, the most influential State Supreme Court in the county, has provided outstanding leadership throughout her 32-year judicial career, and most significantly in her past twelve years as Chief Justice. CAPAJA has been extraordinarily proud to count her among its members and wishes her luck in the next stage of her life and career.

Former CAPAJA President Judge David I. Doi (ret.) Passes Away

It is with deep sadness that we inform you of the passing of retired Judge and Former CAPAJA President David I. Doi on July 6, 2022. He was a beloved brother to retired Justice Kathryn Doi Todd, who is also a Former CAPAJA President. Judge Doi will be dearly missed by those of us who knew him and valued his friendship.

Judge Doi began his career on the bench in 1983 when then-Governor Edmund G. Brown Jr. appointed him to the Los Angeles Municipal Court. Judge Doi's first assignment was in traffic court, and then he served as the presiding judge at the Central Arraignment Court. He was later elevated by unification to the Los Angeles Superior Court in 2000. Judge Doi was assigned to central civil and two years later, he was reassigned to the Edelman Children's Court and handled dependency cases until 2005. In 2006, Judge Doi sat in juvenile court in Compton until he retired on March 3, 2006. For information on Judge Doi's life and career, I have his obituary published in the Los Angeles Times. Looking for Judges Fluent in Mandarin to Translate Judges in the Classroom Script

Judges in the Classroom (JIC) connects public school teachers with volunteer judges for lessons on the role of the judiciary, the three branches of government, rule of law, and other areas of civics. The program is supported by the Chief Justice's Power of Democracy Steering Committee. Participating judges appear in classrooms in person or via zoom to present one of four grade-appropriate lessons. In an effort to provide access for ESL students, two lessons are now available in Spanish and one is available in Mandarin. There is great value in these translations because they are delivered by language fluent judges in immersion classes with non-English speaking students. JIC is seeking judges fluent in Mandarin to translate the script for the Salem Witchcraft Trials presentation. The script is read by students and vividly illustrates how trial procedures have changed from the 1600's to the present.
