#### CAPAJA Members Assist Judge from Japan

CAPAJA Co-Chair for Strategic Partnerships Judge Holly Fujie arranged a series of interviews in Los Angeles for Judge Sho Mizutani, who is a resident Graduate Fellow at the UC Berkeley School of Law and is studying bail and remote hearing issues for the Japanese Courts. Judge Mizutani met with Judge Tim Saito to discuss and observe bail hearings and with Judge Fujie to discuss remote trials. He observed jury selection in Judge Bruce Iwasaki's courtroom. Judge Mizutani met with Chief Judge Phil Gutierrez to discuss remote hearings and trials in federal court and with Chief Magistrate Judge Karen Stevenson to discuss bail proceedings in federal court. He also met with Civil Division Supervising Judge Michelle Williams Court and Judge Mark Juhas to discuss the use of technology in the Superior Court. Judge Mizutani expressed an interest in meeting with judges in Alameda and San Francisco Counties to discuss how their courts handle these issues, so CAPAJA Members in those counties can expect to hear from Judge Fujie with that request!
