The July 2021 CAPAJA member survey will be distributed soon and will be on the CAPAJA Annual Meeting at the CJA Annual Meeting in Monterey on September 23-26, 2021. There will be a crucial vote at the CJA annual business meeting on Sunday morning, September 26, on whether CAPAJA and other affinity judge groups should have a seat on the CJA Board. The vote requires a 2/3 majority to pass, and you must be present to vote. So CAPAJA needs its members to vote in person for a board seat. We are working to schedule the CAPAJA Annual Meeting for just before the CJA business meeting, so this will be a great opportunity to connect in person with your colleagues and friends from all over the State, and then vote on getting a CJA Board seat right afterwards!

CAPAJA Mentoring Committee Survey

Thank you to everyone who completed our mentoring committee survey. CAPAJA received over 56 responses, both from those who agreed to be mentors and those looking for mentors. The survey will allow our mentoring committee to match mentors with mentees. Many members are looking for mentors to help them in a wide variety of situations – as new judges, as judges starting new assignments, to discuss career development or other positions, and to serve as teachers or leaders in their communities. Fortunately, CAPAJA has many members who generously agreed to serve as mentors in all these capacities and for nearly every legal subject matter.

CAPAJA Participates in Judicial Diversity Summit

CAPAJA President Holly Fujie, President-Elect Audra Ibarra and Judge Sonny Sandhu have been actively planning for the Judicial Diversity Summit sponsored by CJA and the California Lawyers Association. The Summit, which includes a kickoff fireside chat, "Judicial Diversity Yesterday" on August 4 at 5 pm, will host additional weekly

educational sessions on August 11, 18, 25, and September 1 and 8. The Summit itself will take place in three sessions at 4:30-6 pm remotely. Summit Day 1 on September 14 will be opened by CAPAJA member Chief Justice Tani Cantil-Sakauye. Summit Day 2, "Sharing What is Working – Side Bars," will take place on September 21, and Summit Day 3, "Judicial Diversity Tomorrow," will be held on September 28. We hope to see lots of CAPAJA members attending.

Governor Newsom Launches California Judicial Mentor Program

On July 1, 2021, the Governor kicked off his statewide judicial mentor program. The program is a joint undertaking between the executive and judicial branches to promote a diverse and inclusive judiciary that reflects California. The program includes both an Appellate Court Mentor Program and Trial Court Mentor Program to demystify the application process, improve transparency and develop a larger qualified and diverse applicant pool. The California Judicial Mentor Program's executive committee is chaired by Judicial Appointments Secretary Luis Céspedes and includes CAPJA member Judge Erica Yew, representing large and medium counties.

LASC Commissioner Evan Kitahara Profiled in DJ

Judge Bryant Yang was recently appointed Chair of the American Bar Association's standing committee on legal aid and indigent defense (SCLAID), which is the ABA's oldest standing committee. Judge Yang was also elected Chair of the Criminal Justice Section of the Los Angeles County Bar Association.

As one of our most recently appointed judges, he is taking leadership for APA judges on both the national and the local scenes to new levels.

LA Superior Court Judge Wesley Hsu and U.S. District Court Magistrate Judge Steve Kim were elected to membership in the American Law Institute (ALI). The ALI, which creates the Restatements of the Law, the Model Codes, the Uniform Commercial Code, and Principles of the Law, selects only exceptional scholars, judges, and attorneys for membership, and vets nominated candidates based on professional achievement and demonstrated interest in improving the law.
